### SECTION 4: First aid measures

### 4.3 Indication of any immediate medical attention and special treatment needed

Treatment	: Notes to doctor/physician: Treat symptomatically. High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. ### Hand protection

**Remarks** : Where hand contact with the product may occur the use of gloves approved to relevant standards (e.g. Europe: EN374, US: F739) made from the following materials may provide suitable chemical protection.
