4.3 Indication of any immediate medical attention and special treatment needed

Treatment	: Notes to doctor/physician: Treat symptomatically. High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. Hand protection
