

WORKPLACE SAFETY

Inform your supervisor immediately about all accidents that happened at work or on the way to and from work. Also inform the perma safety engineer immediately so he can report the accident.

If you have an accident at work that requires medical attention, seek treatment only from authorised emergency doctors (see emergency and alarm plan). The responsible accident insurance provider is BGHM (Professional Association for Wood and Metal).

Wear mandatory protective gear - ask your supervisor for further information. Inform yourself about

- » occupational hazards
- » hazardous substances
- » first aid facilities

Follow operating instructions for machines and hazardous substances. Only use materials that have been clearly marked and approved. Never operate machinery without prior instructions and training. Check safety and emergency stop devices at your workplace before you start work.

The use of MP3 players or earphones is prohibited throughout the factory. The use of personal electronic devices and mobile phones is not permitted.

Consumption and possession of alcohol or narcotics is strictly prohibited as you might put yourself and others at risk.

Please contact your supervisor if your state of health impairs your ability to work.

ENVIRONMENTAL PROTECTION

Sort waste and put it into the designated containers for

- » domestic waste

ENERGY MANAGEMENT

FIRE PREVENTION

Fire protection regulations part A, B and C

- Smoking is prohibited throughout the factory | Smoking is only permitted outdoors and in designated smoking areas
- Avoid ignition sources and electrostatic charge | Keep containers closed
- Do not block fire doors and gates | Do not block emergency exits, staircases and escape routes
- Do not block fire extinguishers, wall hydrants or fire alarms

Before any emergency occurs, find out the location of:

- » the nearest fire extinguishers
- » the nearest emergency exits and escape routes
- » the nearest fire alarms and phones

Follow the instructions of the fire safety personnel.

In case of a fire alarm, please proceed to the meeting point. Report to your supervisor.



HEALTH PROTECTION

- Use skin protection items offered by perma (skin protection plan): Protect your skin before you start work, regularly cleanse your skin and use skin care products after work
- Avoid soiling your clothes with hazardous substances | Protect body parts from hazardous substances by wearing mandatory protective gear
- Do not eat or drink at work, especially when handling hazardous substances
- Noise: Hearing can be permanently damaged when noise levels exceed 86dB/A. We strongly recommend the use of ear protection
- Pay attention to safety markings. Read and follow company notices | Use lifting aids when moving heavy loads. Protect your spine by bending your knees when lifting heavy loads
- Corona | Please follow the perma protective measures and hygiene standards (displayed at the reception desk)
